OCTOBER COUNCIL MEETING: The Public Hearing for the USDA Grant/Loan for the purchase of a backhoe was opened at 7 p.m. There were no questions from the audience. Jeanette reported that we should get \$15,000 to \$20,000 grant for the project.

Building permits from the last year have been sent to the Lincoln County Assessor.

A request for our refund levy of \$170 was made to the Assessor also.

Brent was not at the meeting so Darrell reported on the sewer issues from 5th street.

NUISANCE REPORT: Nuisance Officer Darrell Francis reported that 27 letters were sent out. 50% cleaned up. We will now send out enforcement letters. He has a guy in Coulee City that will pick up the vehicles.

Mayors Meeting: Darrell attended the Mayors Meeting in September. Evergreen Rural had a presentation and they discussed the 3/10% sales tax increase and each town reported on what they were doing.

Restrooms: The work is progressing. It should be finished the first part of November.

Wilbur Landfill: We are just waiting for Ed Denzy to make the final closure letter for the old landfill.

NEW BUSINESS: Resolution 2016-91 – Interlocal Agreement with AWC RMSA was approved and signed.

BUDGET: Council began the budget discussion.
